Kami telah mengaudit laporan keuangan **Yayasan Hutan Biru** terlampir, yang terdiri dari laporan posisi keuangan periode 1 Januari 2018 sampai dengan 31 Maret 2019 serta laporan aktivitas, dan laporan arus kas untuk periode yang berakhir pada tanggal tersebut, dan suatu ikhtisar kebijakan akuntansi signifikan dan informasi penjelasan lainnya.

We have audited the accompanying financial statements of **Blue Forest Foundation**, which comprise the balance sheet period January 1, 2018 to March 31, 2019, and the statement of activities, and cash flows for the period then ended, and a summary of significant accounting policies and other explanatory information.

#### Tanggung jawab manajemen atas laporan keuangan

#### Management's responsibility for the financial statements

#### Tanggung jawab auditor

#### Auditor's responsibility

Tanggung jawab kami adalah untuk menyatakan suatu opini atas laporan keuangan tersebut berdasarkan audit kami. Kami melaksanakan audit kami berdasarkan Standar Audit yang ditetapkan oleh Institut Akuntan Publik Indonesia. Standar tersebut mengharuskan kami untuk mematuhi ketentuan etika serta merencanakan dan melaksanakan audit untuk memperoleh keyakinan memadai tentang apakah laporan keuangan tersebut bebas dari kesalahan penyajian material.

Our responsibility is to express an opinion on such financial statements based on our audit. We conducted our audit in accordance with Standards on Auditing established by the Indonesian Institute of Certified Public Accountants. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether such financial statements are free from material misstatement.

*We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.*

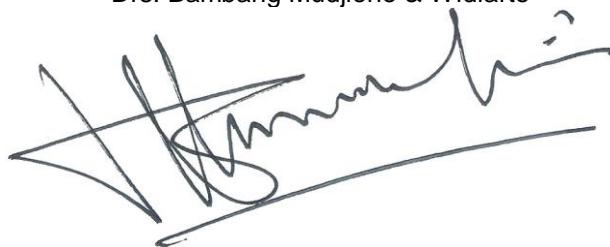
